5.	What OT scripture is mentioned in 8:15 and how does Paul use it to illustrate equality in giving and receiving?	
6.	What are the various principles of giving stated by Paul in Chapter 8? (You will add this list to the principles stated in Chapter 9.)	
Applications for Today		
1.	Generous giving on the part of Christians shows their genuine love (8:1-15; see especially 8:8 and 8:24). What did the widow show at the temple treasury (Mk. 12:43-44)?	
2.	Funds from the local church treasury are given to needy saints only (8:4). Who were the recipients of local church benevolent help in the NT (Acts 2; 4; 6; 11; Rom. 15; 2 Cor. 8-9; 1 Tim. 5)?	
3.	Our commitment precedes our contribution. Christians, who first give themselves completely to the Lord, will have no trouble being generous givers (8:5). Who was given to the Lord (1 Sam. 1:11, 28)?	

- 4. Christians should not simply do the bare minimum or be mediocre; they should abound and excel in their service to Christ (8:7). What else should abound in the Christian (Rom. 15:13; Phil. 1:9; 1 Thess. 4:1, 10)?
- 5. Jesus, who was "rich" in heaven, was willing to become "poor" on earth to save mankind (8:9). What did Jesus give up to save mankind (Phil. 2:6-8)? What did Christ demonstrate by saving mankind (Rom. 5:8-9)?
- 6. The handling of the Lord's money needs to be done by men who have been proven to be honest and trustworthy (8:16-24). What did Paul write about honesty (what is good and right) in Romans 12:17 and what did Peter say about it in 1 Peter 2:12?
